## State-wide Bulk Data Dowloads

Mineral Resources Tasmania is currently undertaking a number of historic geochemical data capture projects. One such project involves the extraction of drill hole sample data from open file exploration reports. This project is ongoing, however significant progress has been made with the near complete capture of drill hole sample and geochemical data back to 2007.

State-wide bulk data downloads from the TIGER database are now available on request, for the following data types:

- Sample and Observation data (surface and drill hole);
- · Geochemical data;
- Consolidated petrophysical data (consolidated sample data and petrophysical results);
- Drill hole data (drill hole collars, and down hole surveys).

Bulk data downloads are available as tabular data in comma-separated values format (csv files). Bulk data downloads are accompanied by an index file and a data dictionary.



The applications exclude existing mining leases, National Parks and reserved or other lands exempted from the *Mineral Resources Development Act* 1995. Both applications are for Category 1: Metallic minerals and atomic substances.

If the licences are granted, consent is required from Mineral Resources Tasmania prior to any exploration activity taking place. An explorer must provide 14 days notice prior to accessing private land. Security deposits are held against each licence in the event that the explorer fails to meet their rehabilitation obligations. Comments on these applications may be lodged with the Registrar of Mines (PO Box 672, Burnie, TAS 7320).

Any person holding a mineral tenement, or claiming an estate or interest in respect of any land within an application area may <u>lodge</u> a <u>formal objection</u> to the granting of that application. Each objection must be in writing and lodged with the Registrar of Mines on, or prior to 18 December 2020. The objection form must be accompanied by the prescribed fee of \$45.36.

Calling the Registrar prior to lodging an objection is recommended in order for the process, and possible outcomes, to be fully explained.
