There are two notices posted for this right one at  
 intake on French's Creek, and one where  
 race crosses Pearce's Creek; both in accordance with Reg.  
 A lease is held for a portion of this race  
 from Fencer's Creek to West side of road 1027/9  
 H. H. Burbury being 11/9. - With a little  
 improvement the race could be made sufficient  
 for both parties. The present holder of  
 11/8 has spent a considerable amount in  
 repairing fluming &c along the portion  
 leased to him.

This race crosses reserved roads many  
 times, but in every case the race has been  
 carefully carried under the road in a  
 culvert.  
 The race will not, further than noted  
 above, interfere with any interests along  
 its course. Of course for the pattern  
 passing through private property arrange-  
 ment will have to be made with the  
 owners.
