* GSNM will work closely with the landowner regarding its proposed work program.

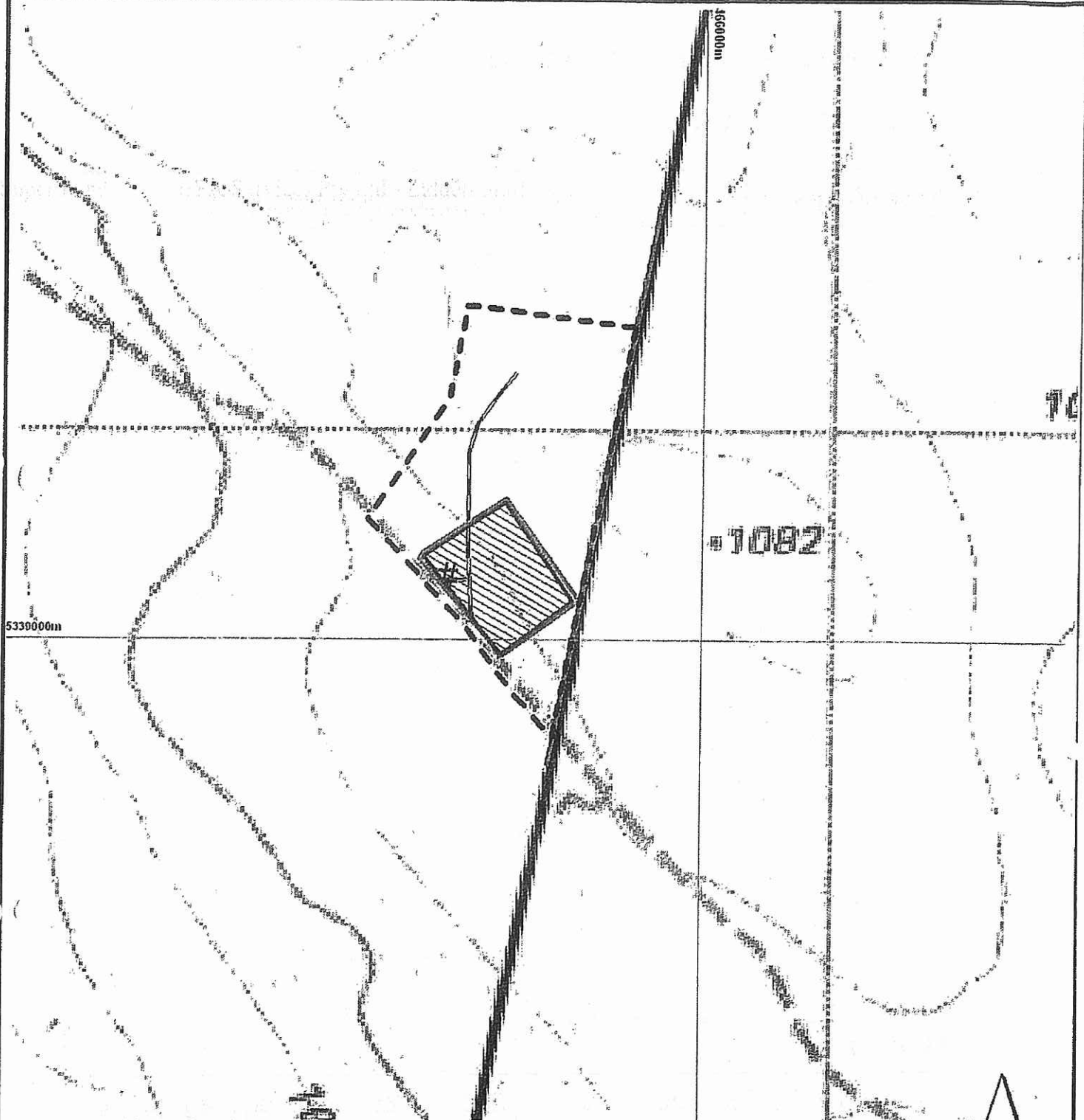
